By participating in the Drawing, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules (the "Official Rules"), and the decisions of A & B Properties Hawaii LLC ("Sponsor"), including the interpretation of these Official Rules, which will be final and binding in all respects.
